CERTIFIED ANGUS BEEF "A" STAMP ASSIGNMENTS

Purpose

This Instruction lists the Certified Angus Beef stamp assignments by applicant and number. An "R" preceding the stamp number identifies Red Angus stamps. Effective November 23, 2009, plants may construct their own "A" and "R" stamps to meet size requirements for export to Mexico. Meat Grading and Certification (MGC) Branch agents will continue to monitor the application of "A" and "R" stamps on the harvest floor either by video or by direct observation. MGC Branch issued and plant constructed stamps must be visible and legible for certification. Both types of stamps shall be controlled by MGC Branch agents when not in use.
